It is the backbone of Ghana's industrial growth and the fourth largest sector of the country's economy

The activities of the manufacturing sector are supervised by the Ministry of Trade and Industry whose primary mandate is to follow through with the implementation of policies for the sector.

OVERVIEW



Prior to the Covid-19 pandemic, the African Development Bank (AfDB) forecasted a 5.9 percent growth in the sector in 2020 as government policies increased production capacity.

Even though the projections have changed, the prospects of the manufacturing sector remain positive due to the implementation of the government's **10-POINT INDUSTRIAL AGENDA**.
